Investment Objective

The investment objective of the Fund is to seek a total return, before Fund expenses, greater than the total return of the Barclays Capital U.S. Aggregate Bond Index using an enhanced core fixed income management approach.

Investment Philosophy

Risk control is the foundation of the Baird Advisors investment discipline. Since interest rates are extremely difficult to consistently forecast over time, Baird Advisors employs a duration-neutral, risk-controlled approach. The duration of the Fund is set equal to the duration of the Barclays Capital U.S. Aggregate Bond Index, thus helping to ensure a high degree of predictability in tracking benchmark returns.

Incremental value is added through security selection, yield curve positioning, sector allocation and competitive execution of trades.

Investment Strategy

The Fund actively invests in the following types of investment-grade debt securities:

- U.S. Treasuries
- U.S. Government Agencies
- Asset and mortgage-backed obligations of U.S. Issuers
- Corporate debt of U.S. and Foreign Issuers

The Fund only invests in U.S. dollar denominated debt securities rated investment-grade at the time of purchase by at least one major rating agency or, if unrated, determined by Baird Advisors to be investment grade.

Baird Advisors keeps the duration of the Fund's portfolio equal to the Barclays Capital U.S. Aggregate Bond Index. The Fund's dollar-weighted average effective maturity will normally be more than five years but less than ten years. The Fund diversifies its holdings across many different issuers from a variety of sectors.

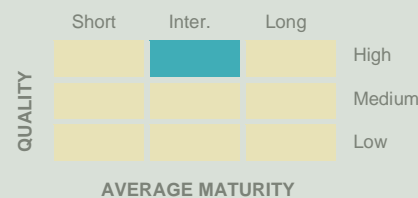

The quality distribution breakdown is calculated on a market value-weighted basis using the highest credit quality rating given by Moody's, Standard & Poor's, or Fitch for each security in the fund.
