⁽²⁾ Robert W. Baird & Co. Incorporated, the investment advisor to the Baird Funds (the "Advisor"), has contractually agreed to waive management fees in an amount equal to an annual rate of 0.15% of the average daily net assets for the Baird Ultra Short Bond Fund until April 30, 2026. The Advisor has also contractually agreed, until April 30, 2026, to waive management fees and/or reimburse other expenses in order to limit the Baird Small/Mild Cap Growth, and Baird Chaustauqua International Growth Funds' total annual fund operating expenses to 1.10%, 1.05%, respectively, of the average daily net assets for the Investor Class shares, and 0.85%, cost, 80%, and 0.80%, respectively, of the average daily net assets for each such Funds' Institutional Class shares. The Advisor has also contractually agreed, until April 30, 2026, to waive management fees and/or, 1.05% of the average daily net assets for each such Funds' Institutional Class shares. This obligation includes interest expense and the fees and expenses incurred by such Funds' investments in other investment companies and excludes taxes, prokerage commissions and extruded expenses were incurred, Fund expenses were incurred, Fund expenses were incurred by reimbursed within a three-year period from the time the expenses limitations described above and in place at the time of the recompenent.
