⁽²⁾ Robert W. Baird & Co. Incorporated, the investment advisor to the Baird Funds (the "Advisor"), has contractually agreed to waive management fees in an amount equal to an annual rate of 0.15% of the average daily net assets for the Baird Ultra Short Bond Fund until April 30, 2027. The Advisor has also contractually agreed, until April 30, 2027, to waive management fees and/or reimburse other expenses in order to limit the Baird Mid Cap Growth, Baird Small/Mid Cap Growth, Baird Chautauqua Global Growth, and Baird Chautauqua International Growth Funds' total annual fund operating expenses to 1.10%, 1.10%, 1.05%, and 1.05%, respectively, of the average daily net assets for the Investor Class shares, and 0.85%, 0.85%, 0.80%, and 0.80%, respectively, of the average daily net assets for each such Fund's Institutional Class shares. The Advisor has also contractually agreed, until April 30, 2027, to waive management fees and/or reimburse other expenses in order to limit the Baird Equity Opportunity Fund's total annual fund operating expenses to 1.50% of the average daily net assets for the Investor Class shares and 1.25% of the average daily net assets for such Fund's Institutional Class shares. This obligation includes interest expense and the fees and expenses incurred by such Funds in connection with such Funds' investments in other investment companies and excludes taxes, brokerage commissions and extraordinary expenses. If such excluded expenses were incurred, Fund expenses would be higher. The Advisor is generally entitled to recoup the fees waived and/or expenses reimbursed within a three-year period from the time the expenses were incurred to the extent of the expense limitations described above and in place at the time of the recoupment, except that the Advisor is not entitled to recoup any fees waived and/or expenses reimbursed for the Baird Equity Opportunity Fund.
